- Citizens who have previously addressed the City Council during Open Forum may only revisit the same matter to request a written progress report once every 90 days. Additional new information may always be submitted to the City Clerk for dissemination to the City Council.
- 4. Matters discussed at Open Forum will typically be referred to Administration with a request for a followup report.
- 5. Any matters involving personnel or insurance claims will be immediately referred to the City Administrator or City Attorney.
- 6. The City Council will not typically take action, but may ask questions to clarify a question or comment.
- 7. Roberts's rules of order will govern the meeting.
- 8. Minutes of the Open Forum meeting will be included in the subsequent City Council meeting packet.
